All electrical work must be inspected by the state electrical inspector. Call (320)275-2151 between 7:00 am and 8:30 am weekdays.

Applicant also understands by signing this application that he/she could be held responsible as representative of this project for any violation of compliance with all applicable laws and ordinances of the City of Hutchinson including survey/plan review notes pertaining to setbacks, easements and property lines.
